

Regular Council Meeting
February 12, 1990
7:00 p.m.

Present: Mayor Alton B. Cumbie; Councilmen: Clarence Phillips, Harry Holladay, "Doc" Evatt, Troy Porter, Frank Chaka, and Stan Thompson; Administrator: Herbert Thompson; Assistant Town Clerk, Catherine Hughes.

Mayor Cumbie called the meeting of February 12, 1990 to order.

Invocation by "Doc" Evatt.

Minutes of the Regular Council Meeting of January 8, 1990 were read and approved as read with motion by Chaka, second by Holladay. Vote unanimous.

1. Stan Thompson: Public Safety - None
2. Frank Chaka: Presented the financial report for the month of January, 1990. Mr. Chaka states that everything is within limits of budget allocations.

3. Troy Porter - Recreation: The need of a policy concerning use of Bolick Field. Mayor Cumbie appointed Porter, Admin. Thompson and Rec. Director Bobby Busha to submit a policy and present back to Council that signs be put up immediately of No Practice Whatsoever On Sundays. *on Bolick Field*
4. Clarence Phillips:- States that the dechlorination for the North Treatment Plant needs to be proceeding.

F) Read an ordinance to accept on first reading property of Miss Eunice Greene, location on Johnson Road into Town of Central. Motion by Holladay, second by Chaka to accept. Vote unanimous.
