Minutes Feb. 13, 1978
Regular Council Meeting

Those Present: Hopkins, Thompson, Porter, Shields, Rollins, Boyles, Administrator John Bethea, Chief Duncan, Clerk Treas. Hughes, Representatives from Harwood Beebe Co.

Mayor Pro tem Thompson, called the meeting of Feb. 13, 1978 to order. Minutes of the last council meeting were read and approved as read.

Police Dept.

1. Radio Problem-- Chief stated according to Larry Turner the problem(\$53. with our frequency was Six Mile Mountain and that Norris would (Larry) be added to our radio system which should make our system better. (TURNER) Motion by Shield to accept Motorola's bid at 64.80 per month. Council Appro
2. Chief Duncan stated to the council that James F. Dixon had been hired for the partime police officer.
3. Chief stated that there had been 3 break-in within the past month. Total lost of \$800.00 2 leads but nothing solved.
4. Cheif stated that Cannon's review was due this month but had no recommendation. (Executive Session)
5. Cheif stated that the new car had been purchased, should receive in a week to 10 days. Purchased through the Ford Co.

Rollins ask the question which car to get rid off, Chief suggestion was to sell the chev. police car. Council agrees with chief's recommendation. Accept bids & advertise.

Repsenatives from Harwood Beebe Co. met with the council and discussed the over run in funds concerning the Pickens County 201 Study and requested that the Town share .25 percent of the total cost. (\$3,200.) The Town of Central would be eligible for funding at 75% regardless whether or not they supported the request of the over run. Motion by Porter to adopt the 25% over run in the Pickens County 201 Study. Motion seconded by Hopkins. Council approved.

Bethea stated that a letter had been mailed from the Town attorney(Calvin) Acker & Acker concerning Business License & the Zoning Ordinance. (Mann)

Thompson asked Rollins to look into building cabinets & closing in the phones and radio equipment in the Fire Dept.

Bethea was to check into a pay phone at the side of the Fire Dept.

Request from Hal Garrett of property owned by Central Concrete & Plaster annexation of lots located on Christy Circle joining Kel Car Acres (4) lot and sts. Motion by Hopkins 2nd by Rollins. Motion carried.

Bethea drew a policy concerning future developments for water & sewer etc. After discussion Council ask that this be put in writing and presented at the next regular meeting.

St. Dept. Committee to check into St. Lights at Central Auto Parts and report at next regular council meeting.

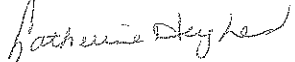

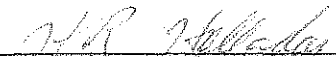
Betha to draw and Ordinance concerning Garbage Pick Up at Business Places.
