1988 MEETING WERE READ. MOTION BY MR. CHAKA TO ACCEPT AS READ, SECOND
BY MR. LAW. VOTE UNANIMOUS.

OLD BUSINESS:

Mr. Law--Public Safety--Gave Police Report.

Mr. Chaka--Gave Financial Report. Discussion of water and liability
insurance figures on financial report.

Mr. Porter--None.

Mr. Phillips--Discussion of East Clemson Water District situation.
Mayor made motion to apply for grant, second by Mr. Chaka. Vote
unanimous. Discussion of Jack Ray situation, further investigation
into the matter will ensue.

Mr. Holladay--Got application for Small Towns Program. Update by Mr.
Holladay on Small Town Program progress. Received \$100 from the
Lion's Club and \$100 from the Town. Requested approval to use the
Town's Tax exemption number for checking account. Motion to approve
by Mr. Law, Second by Mr. Phillips. Vote Unanimous.

Mr. Evatt--None. Mr. Law had question on unlocked gate at the park on
Gaines street. Needs to be locked back.

NEW BUSINESS:

Mr. Law--Present resignation of Miss Maw. Motion by Mr. Chaka to
accept resignation, Second by Mr. Law. Vote Unanimous. Miss Maw
recognized.

Mr. Chaka--None.

Mr. Porter--Good turn out for softball, T-ball and Jr. softball teams.
Update on adult men's Open League. Discussion on keys to gate and
concession stand situation.

Mr. Phillips--Mayor wanted to offically thank Blue Ridge for helping
in clean-up. Discussion of future clean-up plans.

Mr. Holladay-- Mayor advised on Planning Code Enforcement Plan. Mr.
Holladay and the Mayor to get more information for next work session.

Mr. Evatt-- Lots of potholes on Pepper street. Mayor advised low on
help right now.

Mayor's Report--Update on Festival for the Town. Plans are tentatively set for Labor Day Weekend. All profits will go into the Small Towns Program. Mayor request use of tax exemption number.

Motion by Mr. Porter to make as a Town Policy that no equipment to be used on private property or taken out of town limits without prior approval by Council, Second by Mr. Law. Vote unanimous.

Motion to move into executive session by Mr. Chaka, Second by Mr. Law. Vote unanimous.

Council came out of executive session into Public session.

Motion made by Henry Law to hire Teresa Crowe for Administrative Assistant, seconded by Mr. Chaka. Discussion was held. Vote 4 in favor 3 opposed.

Motion was made by Clarence Phillips, seconded by Mr. Law to hire Herbert Thompson as Administrator. Discussion was held. Vote unanimous.
