JUNE 12, 1978 MINUTES REGULAR MEETING COUNCIL

Present: Hopkins, Thompson, Porter Rollins, Boyles, Chief
Besser & Clerk Hughes.

Mayor Pro-tem Thompson called the meeting to order and the minutes of the last council meeting were read and approved as read with the exception as to the police chief's position being cleared as Chief rather than acting Chief.

Police Dept.

Chief Besser presented to the council the activity report from his dept. for the month of June.

Besser read the resignation submitted from Kenneth L. Gilstrap to be effective June 15, 1978. Reason for separation was other employment.

Rollins suggest that radar be run on Gaines St. & Maw Bridge Rd.

Motion by Rollins second by Hopkins to adopt the first reading of an ordinance of selling the 1974 Chev. police car. Motion carried.

East Clemson water rates was in discussion concerning an agreement between the East Clemson Water District commissioner's in 1971 of minutes of East Clemson Commissioner's that at the present time the Town of Central would not increase the rate more than the wholesale increase to the Town of Central. After discussion the council felt that there was no contractual agreement between the parties and the increase of .11 per thousand effective May 1, 1978 would remain in effect.

Council gave the authority for Clemson Exterminating to exterminate the Community Park Building and also authority for plumbing to be done in the said building (restrooms).

The sign has been placed at the Central Part Entrance and Tennis Courts.

No price has been established for vandal toilets for the restrooms at the park. Mrs. Boyles was to look into this matter and present back to the council.

Council stated to continue with Blue Cross Blue Shield Insurance for the employee's of the town.


Motion by Rollins seconded by Porter to hire Jay Cooper for the water engineering on the said property above. Motion carried.


