Minutes Regular Council Meeting June 13, 1977

Those Present: Kennemore, Hopkins, Rollins, Porter, Thompson, Boyles, Town Administrator Bethea, Mayor H.R. Holladay, Clerk Treas. Catherine Hughes, Chief of Police Duncan, New Media (Messenger) Mr. Mitton (Duke Power), Boy Scout Leaders (Phil Gibson) & Jim Evatt.

Mayor called the meeting of June 13, 1977 to order. Minutes of the last regular council meeting was read and approved as read.

Motion by Hopkins seconded by Rollins to rent and sign a (3) year contract with Carpenter Decorations for (10) 8 ft. Red Candles @ \$35.00 each, (10) 8 ft. Red Lanterns @ \$ 35.00 for Christmas decorations. Motion carried.

Police Chief Duncan recommended an increase in pay for patrolman Kenneth Gilstrap. Rollins committee of the police dept. recommended a \$7.50 week increase. In discussion Kennemore stated that he felt that Gilstrap should make same as other patrolman. Motion by Rollins, seconded by Hopkins to give \$7.50 week increase. 
After checking with State concerning water tank State says to do away with tank will not effect Fire Ins. rates.

Report on Mt. Zion Cemetary--Ordinance to create commission for Mt. Zion cemetary taken into consideration. No action taken.


Motion by Thompson seconded by Hopkins to accept final reading on Business License Ordinance. Motion carried.
