Meeting
Aug. 14, 1978
Minutes

Those present: Mayor Holladay, Councilmen: Hopkins, Thompson, Boyles, Rollins, & Porter: Administrator Jones, Clerk Treas. Hughes: Chief of Police Besser & Nancy Snell with the Messenger.

The meeting of Aug. 14, 1978 was called to order by Mayor Holladay and minutes of the last regular meeting July 10, 1978 & minutes of the called meeting of Aug. 3, 1978 were read and approved as read with the exception of correction to the minutes of the called meeting of Aug. 3, 1978 to read of a fee of \$625. per building rather than \$3,750. as per agreement read by Mr. Jones between the Town of Central & Robert Newton & Alfred Lehman. The agreement was signed by Newton & Lehman Aug. 9, 1978. Motion by Hopkins seconded by Porter to approve this agreement of \$625. per building rather than \$3,750. Motion carried.

Chief Besser gave his departmental active report for the month of July 1978. See copy attached to financial report office copy.

Mr. Jones & Chief Besser presented to the council a organization chart of rank schedule for the police dept. (Lt., Sgt., Corporal & patrolman.) After much discussion council decided to table until the meeting on Aug. 21, 1978.

Motion by Thompson seconded by Rollins to adopt the employee wage scale grad 1-10. Motion carried. (See Attached copy.)

Mr. Jones read a request from Weldon Day (Pickens County Council) concerning the purchase of gasoline for the Ambulance Service located on Hwy 93 from the town supply. Council suggest that Mr. Jones talk with Mr. Day and explain our situation and work out something with Mr. Day.

Motion by Thompson seconded by Hopkins to adopt the following resolutions.
1. To adopt approving area Wastewater Facilities Plan and Intention to Implement the Plan as a Designated Management Agency (208)
2. To adopt approving Regional Water Quality Management Plan and willingness to Proceed as Management Agency. (201). Council approved.

Motion by Thompson seconded by Rollins to purchase a answering devise for the police dept. \$195. plus installation of Southern Bell Telephone. Council approved.

Council gave Mr. Jones (Administrator) the authority to approve the A-95 form from COG (Council of Governments). If any questions call any council members.

Discussion of secretarial help (Grace Towe) was discussed of 3 days rather than 2 days. This matter was tabled until the Aug. 21, 1978 meeting until further figures could be compiled.
