A Special Call Meeting of the Town Council was held on Thursday, January 15, 1970 at 5:30 P. M. with the following attending: Mayor, L. S. Griffin, Councilmen C. B. Bryan, J. R. Herd, W. W. Norwood, Herbert Thompsen, Jr., George Fowler, and A. R. Cureton.

Mayor Griffin presided over the meeting.

An announcement was made that the Pickens County Municipal Association would hold it's monthly Meeting at Central on Monday, January 19, 1970 at 7:30 P. M.

Present for the meeting was ~~XXXXXXXXXXXX~~, Wess Adams, applicant for the Police position. After discussion, Councilman Cureton made a motion seconded by Councilman Fowler that Mr. Adams be hired for the Position of Police provided that he sign an agreement concerning this position. This motion was made to the effect that Mr. Adams would be acting Chief of Police until another man was employed and then a Police Chief would be appointed by the Town Council. Five Councilmen voted for the employment of Mr. Adams and one voted against his employment. The employment of Mr. Adams to begin on Saturday, January 17, 1970.

There was some discussion as to the uniforms for the Police. After some discussion on this matter, Councilman Cureton made a motion seconded by Councilman Fowler that the Town outfit the Police and then when or if he ever leaves the Town, the uniforms would go back to the Town of Central.
