Call Council Meeting
May 13, 1977

Those present: Mayor Holladay, Councilmen: Hopkins, Thompson, Porter, Kennemore, Incumbency: Jay Rollins & Phyllis Boyles, Town Administrator, Clerk & Treas. Catherine Hughes, Rep. from Howard Harrill Company, Forrest City N.C.

Mayor Holladay called the meeting to order in which the Swearing in Office Under Oath of the new incumbency Phyllis Boyles, replacing an unexpired term of Steve Bolt whose term was to expire Sept. of 1980 and Jay Rollins replacing an unexpired term of Billy Joe Busha whose term was to expire Sept. 1978.

After Swearing into Office Mayor Holladay welcomed the new councilmen and appointed Mrs. Phyllis Boyles to the Parks & Recreation Committee and Jay Rollins to the Central Police Dept. Committee.

Minutes of the last regular council meeting were read and approved as read with the exception of Kenneth Gilstrap's review which was brought up at this meeting. Council felt that since this was a call meeting and Chief not present to postpone until our next regular council meeting. June 13, 1977.

Meeting with the council was a representative from Howard Harrill Company concerning the Christmas decorations which has been on an lease plan for the past three years and expired Dec. 1976. At this time it was up to the town to reconsider another contract or change in decoration. This representative gave the prices and different kinds of decoration along with photo of each. They are as follows: 1) Sea Scroll 8ft. \$41.50, 2) Sea Scroll 6 ft. \$43.50, 3) Tear Drop 8ft. \$52.50, 4) Diamond Tree 7ft. \$46.00, 9ft. \$50.00, 5) Triangle Tree 7ft. or 9ft. \$50.00, 6) Wreath Tree 8 ft. \$46.00, Christmas Tree 7ft. \$50.00, 9ft. \$55.00, & 7) Vertical Tree 8ft. \$49.50. A rental extension for the same decorations for 1 year only for \$360. + tax. Mayor Holladay asked councilmen Thompson & Kennemore to work with John Bethea and Clerk to decide what is needed and what design for decorations.

Councilman Porter stated to the council the question that had been asked him by Massingill concerning sewer for his trailer park located down Madden Bridge Rd. so that an answer could be given to Mr. Massingill. Bethea stated that Mr. Massingill had given to him a report from his engineer and he in turn gave to the Town engineer (Beeson) who stated that it would


