CALLED COUNCIL MEETING

January 9, 1979

The Council met at 7 P. M. with all members present.

The Administrator presented a proposed Community Development Project for the Town and explained all that was involved. He also gave some estimated cost figures. He then introduced Mr. Joe Murray from the Council of Governments, who spoke to the question of the feasibility and prospects for such a development project.


A question and answer period then followed Mr Murray's presentation. Mr. Hal Garret and Mr. John Head of the Community, who also were present entered into the discussion.

Council then passed a resolution authorizing the submission of a preapplication to HUD, (resolution attached)

Council moved to meet again on January 16th in further discussion of this program in order to give Mr Murray some definitive guidelines on how to proceed.

Another Public meeting for the purpose of holding a second hearing on the Community Development Project was scheduled for January 23rd at 7 P. M.

The Administrator explained to Council that our insurance policy was due another yearly payment in February. It had been the policy of the Town to bid this policy every year. He recommended that since a policy is written for three (3) year periods, that bids not be taken again until the three (3) year period expires. Council approved.
