MINUTES

SPECIAL CALLED MEETING

February 5, 1979

The Council was called to order by Mayor H. R. Holladay at 7 P. M. All members present with the exception of Councilman Evatt.

*1st
Jan 8, 1979* } The Mayor called for the second reading on the Street Number Ordinance and Ordinance on Use of Town Equipment and Employee. No objection, the ordinances were passed.

It was moved and passed that the Town Administrator meet with the Fire Chief and negotiate an hourly rate for making Fire Inspection each quarter.

Councilman Thompson moved and seconded by Councilman Chaka that the zoning variance requested by Southern Bell be granted. The motion passed without opposition.

The council agreed to let the Mayor appoint a new Zoning Board of Adjustment since the previous board term had expired.

Councilman Thompson moved and seconded by Councilman Hopkins that the Job description for Building Inspector be approved as presented. Motion passed without opposition.

The Council tabled the Water Department Policy.

Councilman Hopkins moved and seconded by Councilman Porter that the Water and Sewer specifications presented by our Town Engineer Mr. Rogers be adopted. Copy Attached.

The Council gave its consent for the Fire Chief and the assistant to attend the State Fire Convention in June at Myrtle Beach.

A report was given by the Administrator on the Senior Citizen project. He had received a call today that it was approved and a contract was in the mail for signature by the Mayor.

He further briefed council on the possibility of additional low cost housing being added to the town by S. C. Housing Authority and by a Real Estate concern from Anderson.



Minutes Feb. 5, 1979 Cont'd:


The Mayor briefed Council on the Proclamation he issued declaring February 6, 1979 Frank H. Chastain, Appreciation Day.
