

**TOWN OF CENTRAL  
REGULAR COUNCIL MEETING MINUTES  
1067 WEST MAIN STREET - CENTRAL, SC 29630  
MONDAY, JANUARY 12, 2026 – 7:00pm**

The meeting was called to order by Mayor Andrew Beckner who also rendered the opening prayer.

***Public Session***

- It was noted that no members of the public had signed in to speak
- Public session was closed

***Swearing-In of New Mayor***

- Mr. Dill took the oath of office, affirming:
  - He is duly qualified according to the Constitution of South Carolina
  - He will preserve, protect, and defend the Constitutions of South Carolina and the United States
  - He will faithfully discharge the duties of Mayor of the Town of Central and work to preserve the peace and carry out the laws

***Recognition of Outgoing Mayor***

- Former Mayor Andrew Beckner was recognized for his service
- A plaque of appreciation was presented to him for his commitment, dedication, and service as Mayor of the Town of Central from 2021 to 2025

***Swearing-In of New Council Members***

- The following newly elected council members were sworn in:
  - Daniel Evett
  - Doug Barry
  - Robert Griffin
- Each took the oath of office to:
  - Faithfully discharge their duties

- Preserve, protect, and defend the Constitutions of South Carolina and the United States
- Serve as council members for the Town of Central fairly and impartially

#### ***Recognition of Former Council Member***

- Paige Bowers was honored for her long service
  - 16 years of service as a councilwoman
  - Over 15 years of service on the Planning Commission
- A plaque was presented to Mrs. Bowers that stated that her hard work and dedication left a positive impact on the Town of Central and the community

#### ***Appointment of Mayor Pro Tem***

- As required annually, a Mayor Pro Tem was appointed
- Nominations:
  - Curtis Peek – nominated by the chair
  - Joe Moss – nominated by Paige Bowers
- After nominations were closed, council voted by raising right hands:
  - Votes for Curtis Peek: 4
  - Votes for Joe Moss: 3
- Curtis Peek was elected Mayor Pro Tem
  - Congratulations were extended to Mr. Peek

#### ***Receipt and Disposition of Petitions***

The Town Administrator reported receipt of a petition from Jimmy Head for 100% freeholder annexation (or related matter as referenced)

- The clerk was directed to note this for February and place on the February work session agenda for council consideration.

#### ***Administrator's Report – 2026 Project Overview***

The Town Administrator provided an overview of key infrastructure projects and grants expected over the next 12 months, with handouts distributed to council and the public.

- **Green Crescent Trail – Downtown Segment**
  - Scope: From the downtown caboose to the Southern Wesleyan University property
  - Bid Timeline: Expected to go out to bid in March 2026
  - Total Project Cost: Approximately \$1,143,000
  - Grant Funding: Approximately \$1.06M (as stated)
  - Town Contribution: \$82,586
  - Schedule: Expected to be completed during the 2026 calendar year
- **Brock Street Water Line**
  - Status: Near completion; work began approximately three months ago
  - Total Project Cost: Approximately \$1,500,000

- Grant Funding: \$1,455,000
- Town Contribution: \$53,220
- Completion Target: Expected by April 2026 (within the next four months)
- Additional line replacements are being added to fully utilize remaining grant funds
- **Mawbridge Road Sewer Replacement**
  - Bid Date: Targeted for April 2026
  - This is the final phase of a full town-wide sewer system rehabilitation effort that has been underway for roughly 20 years
  - Total Project Cost: Approximately \$2,000,000
  - Town Contribution: Not to exceed \$150,000
  - Once complete, the entire system is expected not to require similar rehabilitation for at least 50 years

***Total 2026 Infrastructure Investment***

***Total infrastructure investment (calendar year 2026): ~\$4,650,000***

***Town's total share: ~\$340,000***

***Grant-funded work in 2026: Approximately \$4.3 million***

- **Fire Station Project**
  - The town has been awarded a \$2,000,000 grant toward a new fire station
  - Estimated total project cost: ~\$5.5 million
  - Additional grants and value engineering will be pursued to close the gap and make the project feasible
- **Additional Grant-Funded Positions/Projects**
  - The Administrator noted this overview covers only grants he directly led
  - Other departments also secure grants:
    - Police Department currently has two grant-funded police officers
    - The recreation department receives grants as well
  - Administrator will continue to provide regular updates as projects progress, especially those that may temporarily disrupt traffic

**Traffic Impacts**

- Green Crescent Trail: expected to be visible but not significantly disruptive
- Mawbridge/Mauldin Road sewer work: expected to involve intermittent lane closures, not full road closures, to minimize disruption

No further questions from council

***Mayor's Report***

- Appointment to Board of Zoning Appeals (BZA)

- Mayor Pro Tem Peek reported that he had contacted a local citizen regarding a vacancy on the Board of Zoning Appeals, explained the duties, and the citizen was eager to serve.

- Staff will extend the formal invitation to Mr. Bradford

### **Temporary Committee Assignments**

The mayor announced committee leadership assignments for council members, effective for this month. Assignments may be adjusted in February after individual conversations to ensure the best fit and compliance.

- **Finance & Marketing:** Daniel Evatt
- **Streets & Public Safety:** Joe Moss
- **Enterprise & Community Engagement:** Lynne Chapman
- **Recreation:** Robert Griffin
- **Planning:** Curtis Peek
- **Tourism & Economic Development:** Doug Barry

These assignments may be revisited next month to ensure “the right people in the right places.”

### **Annual Meeting Schedule**

- A schedule of all projected council meetings (work sessions and regular public sessions) through December 2026 has been published
- The schedule is:
  - Posted on the town website, and
  - Posted in the lobby at Town Hall
- Residents can use this to plan ahead. If meetings must be canceled, it will be done in compliance with required notice procedures.

### **Mayor’s Closing Remarks**

The new mayor offered personal remarks and his guiding principles:

- **Gratitude & Honor**
  - Thanked the people of Central for entrusting him with the honor of serving as mayor
  - Expressed humility and commitment to working with both elected officials and staff
- **Commitment to Action**
  - Early in his career, a moment of inaction made someone feel he did not care
  - Since then, he has resolved that if he makes mistakes, they will be mistakes of action, not inaction, so people know he is trying and cares
  - Residents should expect changes in the coming months that provide more information and greater transparency
- **Transparency & Accountability**
  - The mayor stated he believes citizens are smart and can handle information; he wants actions to be as transparent as possible
  - On the back of his office door, he has taped his campaign promises, so he can:
    - Regularly see what he pledged to do
    - Check them off as they are fulfilled
  - He emphasized that his integrity with the community is of high importance
- **Doing the Right Things, the Right Way**
  - He wants the town to do the right thing and do it the right way
  - Acknowledged it is possible to do the right thing in the wrong way, and said they will avoid that
  - Some processes may seem slow because of necessary checks and balances; he asked for patience as the town works through those processes correctly
- **Appreciation for Staff**
  - He praised town employees across departments—fire, police, streets, and all others—for their work protecting and serving the community
  - Encouraged residents to come meet the staff and see “the great team” serving the town
- **Vision for the Future**
  - Stated he believes Central is “the best town.”
  - Believes that by working together, doing the right things in the right way, the best days are ahead for the community

## **Adjournment**

There being no further business, the Mayor Pro Tem declared the meeting adjourned at approximately 7:24pm.
