# Second Reading of Ordinance #06-12-2023 BU (18 Fund Sanitation)

Lynne Chapman made the motion to adopt on second reading of Ordinance #06-12-2023 BU pertaining only to the 18 fund (Sanitation); seconded by LC Hayes. Paige Bowers recused herself due to a family member employed in this department. The vote was unanimous with 1 recusal.

#### Second Reading of Ordinance #06-12-2023 BU

Paige Bowers made the motion to adopt on second reading of Ordinance # 06-12-2023 BU for funds containing 10,12,13,20,30,32,33,35,40,60,71,80, and 85 funds; seconded by LC Hayes. The vote was unanimous.

Mayor Pro-Tem Joe Moss stated that in Conjunction with the Budget, Council needed to give him the authority to enter in Negotiations with the Administrators Contract. Ken Dill made the motion to give the Mayor Pro-Tem Joe Moss to enter into negotiations with the Administrators contract in conjunction with the budget; seconded by Lynne Chapman. The vote was unanimous.

#### Second Reading of Ordinance # 06-12-2023 RB

Lynne Chapman made the motion to adopt on second reading Ordinance #06-12-2023 RB; seconded by Ken Dill. The vote was unanimous.

#### Second Reading of Policy #06-12-2023 BASE RATES

Paige Bowers made the motion to adopt on second reading Policy #06-12-2023 BASE; seconded by Lynne Chapman. The vote was unanimous.

Paige Bowers made the motion to adopt Ordinance #06-12-2023 BL; seconded by LC Hayes. The vote was unanimous.

# Reports from the Administrator and Mayor:

#### A. Administrator

Phillip Mishoe said we need to pass an ordinance by the end of August. We need to establish who is going to be in the ANATS. The person over the

ANATS is going to recommend who our representative should be. The municipality will have one representative. It said it could be Mayors or Council Members. He said we have to commit into going into ANATS before the board is established. They will estimate the money. He said the Feds make that decision. He said they were probably going to be a Pickens County Council to represent. He said that would give us 5 or 6 people where we only had 1 with GPATS. All this is not set. We should be getting more accurate guidelines. Ken Dill ask how many people were leaving GPATS. Phillip Mishoe said only Pickens County.

Phillip Mishoe said the Church Street water line project is going. He said they started a Peco/Jerry's Pizza. He said it has been a year since we bid the project out. We are glad that it is finally starting.

## B. Mayor Pro-Tem

Mayor Pro-Temp opened the floor for discussion of the roads. Phillip Mishoe said he had sent them all the spreadsheets to see what roads were in most need. He asked them to study these and needs direction on what roads need to be on the list. They discussed different options to do. Phillip asked them to come back with recommendations at the work session. He also told them since our Work Session will be right before the regular meeting they needed to be prepared to vote at the regular meeting in July.
